**Subject:** URGENT: Life Insurance Reminder

Dear Friends,

### Have you posted in your Life Insurance Opt-in forms?

If you have a life insurance policy attached to a super fund to which you are not currently making contributions, under a new law you are required to 'opt in'.

From 1 July 2019, super funds will be required to cancel insurance on accounts that **haven't received contributions for at least 16 months**.

### **Your fund will contact you if your insurance is about to end.**

If you want to keep the insurance, you must tell your super fund, or make a contribution to that account. You may want to keep your insurance if you don't have any other cover through another fund or insurer or you have a particular need for it (e.g. you have children or other dependants or work in a high-risk job).

You should have received a letter or email from the insurer regarding your need to opt in. You will only receive this communication if your fund has been inactive for the period prescribed above.

The deadline for reply is 30 June 2019 – but remember, that is a Sunday. Therefore, you need to advise the fund (in writing) before 28 June if you want to retain your cover.

By law YOU must do so, as we are not able to act in this matter on your behalf.

**If you are not sure, the best course of action is to opt in** – and then discuss it with us at your next appointment. If your insurance is cancelled, you may NOT be able to re-instate or replace it (bear in mind too, that Marinis Financial Group does not accept commissions on life insurances we recommend).

If you have any questions, please call the super fund. Their details will be on the letter you will have received.
